



## The Year's Highlights

**HSC's Edgewood group home received LEED (Leadership in Energy and Environmental Design) from the United States Green Building Council.** The Edgewood facility is the only LEED certified building in Lawrence County. It is the only group home in the United States to receive this recognition.

**The Center was accredited by The Sanctuary Institute in New York. This accreditation permits the Center to employ the Sanctuary model throughout our services.** The Sanctuary model was developed by Dr. Sandra Bloom; it established an organizational environment that promotes empowerment.

**HSC implemented a client-run business that is affiliated with its Fairweather Lodge program.** This program and its related businesses are recognized throughout the Commonwealth and serve as models for other agencies. Steve Plyler, who initiated this program, has provided consultation to a number of non-profit organizations.

# Annual Report

## 2007-2008

Each year in our annual report I usually provide a summary of the major accomplishments of the Center, or a discussion of a trend in the mental health field that impacts our agency. However, a more poignant event took place in June that overshadows our reporting on public policy issues or the achievements of the Center. On June 22, 2008, HSC's medical director, Dr. Shoukry Matta, passed away following an extended struggle with pancreatic cancer. He left our agency after serving as our medical director for 30 years – touching the lives of thousands of our clients. In his own quiet and compassionate way, Dr. Matta defined who we are as an agency and how as mental health professionals we should care for the clients we serve. He will be sadly missed by all who knew him.

The loss of Dr. Matta is a reminder of how important the human component is to our agency. Without a dedicated staff, the Human Services Center would not have realized all its accomplishments and the nearly 3,000 clients we serve each year would not have received the professional

care they deserve.

Public mandates for programs are obviously important to any social service agency. However, they cannot be realized without a staff of dedicated professionals who believe in what they do. This dedica-
